They are NOT expecting a vehicle(s) to pull up...this problem is growing & needs to be addressed ASAP please.

We would like to request the RM post **No Vehicles Past This Point** signage. Signs need to be posted at our 3 green spaces location at;

West St & 102 / Volleyball Court sign, plus new pillars to be added to existing row of pillars in order to block vehicle entry...Currently there is enough room for vehicle(s) to gain access, drive on the grass, to get close to the shoreline / beach access.

West St & Beach / Basketball Court

West St & Lake Ave / Children play structure

Recently many of our permanent residents & cottagers have approached the Lakeshore Heights Association with complaints of the poor road conditions. Understanding the recent large amounts of rain events have developed pot holes on many of the roads.

West Street needs attention ASAP as there are a good amount of deep pot holes along this high traffic street. Other streets have issues too...PDF area map attached with RED circle on the house number needing repair. Examples as follows:

*In the center of the road ROCK coming up out of the road in front of 20 West St

*Intersection with deep pot holes on West St & South Ave

*One whole curve need attention due to its at the bottom on the hill where 101 turns into West

*South Bay / Ave at the stop sign beside # 70 & 106 South bay, sinking is happening over top the culvert

*Lake St ...NO Street sign is posted on this street...also needs attention from top to bottom due to major water flow during heavy rain going down this road way

*Beach Blvd needs attention at the top & bottom again due to rain water going down this road way.

*(map was sent & marked) House numbers circled in RED have Pot Holes issues that need attention

We would appreciate the Public Works Departments attention to address/repair the pot holes as soon as possible or, the latest date of June 29th as this is a long weekend & the population will greatly increase. Thank-you for your attention in the matter.
